Section 1002.31,(2)(b), Florida Statutes

Each school district and charter school **capacity determinations** for its schools, **by grade level**, must be **updated every 12 weeks** and be identified on the **school district** and charter school's **websites**.



2022/23 Seats Available Process

Every 12 weeks

- Principals will identify potential seats available by grade level
- District accepts or requests supporting documents
- District publishes available seats, by grade level, on District website

2022/23 Application Window Closed	August 30, 2022
Space Availability for 2 nd semester	October 2022
Select students for 2 nd semester	Prior to Winter Break
Notify parents for 2 nd semester	Prior to Winter Break
